

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to fidomanagement.com and Fido Management and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Fido Management include fidomanagement.com, and Fido Management. The Fido Management website is a corporate site. By using the Fido Management website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Fido Management may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Employer
- Job Title

Fido Management may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Fido Management collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Fido Management may also use your personally identifiable information to inform you of other products or services available from Fido Management and its affiliates.

## **Sharing Information with Third Parties**

Fido Management does not sell, rent or lease its customer lists to third parties.

Fido Management may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Fido Management, and they are required to maintain the confidentiality of your information.

Fido Management may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Fido Management or the site; (b) protect and defend the rights or property of Fido Management; and/or (c) act under exigent circumstances to protect the personal safety of users of Fido Management, or the public.

## **Tracking User Behavior**

Fido Management may keep track of the websites and pages our users visit within Fido Management, in order to determine what Fido Management services are the most popular. This data is used to deliver customized content and advertising within Fido Management to customers whose behavior indicates that they are interested in a particular subject area.

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Fido Management. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Fido Management website.

## **Use of Cookies**

The Fido Management website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Fido Management pages, or register with Fido Management site or services, a cookie helps Fido Management to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Fido Management website, the information you previously provided can be retrieved, so you can easily use the Fido Management features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Fido Management services or websites you visit.<sup>3</sup>
